| <b>C</b> | Ceased Membership of Conclave.                | Rule 118          | Not paid his Annual Dues <b>for two years</b> .   |
| <b>E</b> | Excluded by the Conclave.                     | Rule 117          | Not paid his Annual Dues. Conclave by-laws allow for such exclusion, following a resolution and a vote by members. Alternatively the Lodge for some other reason following a resolution has excluded him by the members.  |
| <b>S</b> | Suspended from Conclave.                      | Rule 139          | Although suspended from conclave continues to pay Annual subscription and Conclave continues to pay Annual Dues to GIC.   |

| <b>W</b> | Warrant Surrendered.                          | Rule 124          | The Conclave Warrant has been surrendered.  |
| <b>V</b> | Voluntary Resignation <b>from ORDER</b> .     | U.G.L.E. Rule 183 | Exercised right to resign from the Order for a variety of possible reasons, including those associated with his employment. Grand Lodge should be contacted at the appropriate time for clarification if the circumstances of the Brother concerned change and he expresses a wish to rejoin. |
